Horse Trial (HT) - \$75 (Dressage, Stadium Jumps in Field, Cross Country Jumps in varied terrain – courses not timed)

- 12": Intro A (Pre-Amoeba)
- 18": Intro B (Amoeba)
- 2': Intro C (Tadpole)
- 2'3": BN A (Bullfrog)
- 2'7": BN B (Beginner Novice)

Combined Test (CT) - \$50 (Dressage and Stadium Jumps – jump course not timed)

- Poles: Simple Dressage Test (simple test – may have coach in arena and/or leadline)
- 8" - 12" Pre-Amoeba: Intro A
- 12" - 18" Amoeba: Intro B
- 18" - 2' Tadpole: Intro C
- 2' - 2'3" Bullfrog: BN A
- 2'3" - 2'7" Beginner Novice: BN B
- 2'7" - 2'11" Novice: Novice A

Dressage Tests - \$25 ea (minimum 2 tests in large arena – max 3 tests/horse)

- USDF Intro Tests A, B, C
- USEF Training – 2nd Level
- USEF Western Dressage Intro – Basic (WDAA)
- Gaited Dressage – test of choice

SHOW INFO: All dressage tests may have caller except for Novice CT. HT and CT dressage in small arena. Dressage Only competitors are in large arena. Show attire not required. Helmets/boots and neat attire required. Level 3 vest required for Cross Country. Ribbons 1st through 6th place. Lunch/Snacks available onsite. Courses available for walking on prior Thursday after noon. Limited stalls available. No stallions. No dogs.
